The CPE vide ref. 3rd cited informed all the Deputy Commissioner's of Prohibition and Excise and Prohibition and Excise Superintendents stated that,the Govt. vide ref. 1st and 2nd cited extended the excise policy for A4 shops for a period of three (3) months i.e. from 1-7-2015 to 30-9-2015 .Therefore all the Deputy Commissioner's of Prohibition and Excise and Prohibition and Excise Superintendents in the state are requested to extend the validity of authorized A4 retail licences till 30th September 2015 and to furnish the list of such A4 shops whose licences were extended to the Chief Managers/Managers of the Depots by 30 th June 2015 evening latest.

Therefore TSBCL is requested to issue instructions to the concerned to issue stocks to those A4 shops whose licences have been extended from 1st July 2015 to 30th September 2015 as per the list furnished by the Proh. & Excise Superintendents concerned while taking required safeguards.

The CPE further informed that, Deputy Commissioner's of Prohibition and Excise and Prohibition Excise Superintendents shall see that , all the A4 Licensees remit into Government Treasury the proportionate annual licence fee and permit room fee wherever applicable for the extended period of the A4 shop from 1.7.2015 to 30.9.2015 on or before 30th June, 2015 as per the orders issued by in GOs cited at reference 1st and 2nd in order to ensure uninterrupted supply of stocks from TSBCL.

Further the prohibition & Excise superintendents shall renew the licences of those authorized A4 shops for the extended period & those who have remitted the licence fee or on before 30th June 2015 only & completed the required fulfillments for licence and furnish the list of such A4 shops/licensees, to the chief Managers/District Managers of the respective IML depots on the following day in order to supply stocks to the licensees without any interruption. The above instructions shall be followed meticulously and no deviation shall be resorted to under any circumstances. Required safeguards shall be taken in the above matter.
