The Govt., through the ref 1st cited, issued instructions for deducting Rs.20/- and Rs. 50/- from the salaries of Non-Gazetted and Gazetted Officers of the State Govt., every year from their salaries of December month towards the Flag Day Fund collection & contribution and remit the same to the Director, Sainik Welfare, Hyderabad through Online Payment. The particulars of account of Director, Sainik Welfare.

Vide ref's 2<sup>nd</sup> & 3<sup>rd</sup> cited, the Govt., has amended the employees contribution from Rs.20/- to Rs.100/- per head from the Non-Gazetted employees and from Rs.50/- to Rs.200/- per head from the Gazetted officers, and requested all the heads of department of all Heads of offices to deduct every year from their salary of December payable in January.

In view of the above instructions issued vide ref's cited, all the Chief Managers/Managers of IMFL Depots and General Manager (F&A) at C.O., are requested to deduct Rs. 100/- and Rs. 200/- from the staff and Officers respectively (excluding unskilled workers) working in the Corporation, **every year from their salary of December and remit the same to the Savings account of the Director, Sainik Welfare, Telangana, Hyderabad.**
