The Manager I/c. IMFL Depot, Utnoor, Adilabad District, vide ref.4<sup>th</sup> cited, has requested to sanction the Additional House Rent Allowance and Special Compensatory Allowances to the regular employees of IMFL Depot Utnoor Adilabad district as the Utnoor of Adilabad district come under scheduled area as recommended by the Tenth Pay Revision Commission.

The Government enhanced the rates of Additional House Rent Allowance and Special Compensatory Allowances vide G.Os 1<sup>st</sup> and 2<sup>nd</sup> cited above.

Consequent on implementation of Revised Pay Scales of 2015 to the employees and in continuation of the this office Circular 3<sup>rd</sup> cited, the rates of Additional House Rent Allowance and Special Compensatory Allowances are revised and ordered to pay to the employees working at IMFL Depot, Utnoor, Adilabad District as shown below.

## I) Special Compensatory Allowance:

The rates of Special Compensatory Allowance payable in non-mandals, is revised in a slab system on the basic pay drawn in Revised Pay Scales, 2015, with effect from 01-06-2015.

## II) Additional House Rent Allowance:

The rate of Additional House Rent Allowance is revised to 8% of the basic pay of the employee under the Revised Pay Scales, 2015, subject to a maximum of Rs.2,000/- per month with effect from 1-4-2015, in cases, where rent free accommodation could not be provided by the Government to the employees holding the posts to which rent free accommodation shall be provided by Government as per rules.

The Manager, IMFL Depot, Adilabad, is requested to take further action accordingly.
