The Government vide G.O. cited, sanctioned Telangana Increment to the categories of employees serving the Government of Telangana in the nature of Special Pay equivalent to the immediate previous increment drawn in their current pay scale in RPS-2010, with effect from the Month of August, 2014.

The Board of Directors vide their Circular Resolution dated:07-01-2015, resolved to sanction Telangana Increment in the nature of Special Pay to the employees of TSBCL, which is equivalent to the immediate previous increment drawn in the current Pay Scales of RPS-2010 with effect from the month of August, 2014, as per the G.O.Ms.No. 23, Finance (HRM-III) Department, dt.13-08-2014, in pursuance to the permission granted by the Government in the reference 3rd cited.

Accordingly, all the regular employees of the Corporation are sanctioned Telangana Increment (Amount equivalent to the increment drawn with effect from August, 2014) in the nature of Special Pay equivalent to the immediate previous increment drawn in their current pay scale in RPS-2010, which would be a permanently fixed amount, during the entire period of service (like earlier Family Planning Increment), with effect from the Month of August, 2014.

The above sanction shall also extend to such of the employees who are presently not ordered to serve provisionally to TSBCL but are finally allotted to the TSBCL on and with effect from the date/month of their reporting in the TSBCL, pursuant to such final allotment.

The Telangana Increment (special Pay), as mentioned above shall be an amount equivalent to the immediate previous increment drawn in the current pay scale of the post held by the employee in the Revised Pay Scales of 2010.

The Telangana Increment shall be sanctioned by the authority who is competent to sanction an Annual Grade Increment in the pay scale admissible to the employee.

The Telangana Increment shall be shown in the pay bill separately and distinctly as a Special Pay.

The Telangana Increment (Special Pay) shall be a permanently fixed amount separately attached to the pay during the entire period of service and shall not be reckoned for the purposes of fixation of pay on promotion or otherwise in future.

No allowance such DA, HRA,CCA or any other allowance shall be admissible on the Telangana Increment.

The Telangana Increment shall not be taken into account for the purposes of calculation of benefits on resignation/retirement/ death such as Gratuity etc.,

The Chief Managers/Managers of IMFL Depots in the Telangana State, are requested to take further action accordingly.
