Sub: Personnel - TS3CL - Enhancement of D.A. to the regular employees of the Corporation and Government employees working on deputation who are drawing their pay in the Revised Pay Scales of 2015 and 2010 - Orders Issued - Regarding.

The Government vide G.O. cited, have issued orders revising the rates of Dearness Allowance to the State Government Employees drawing pay in the Revised Pay Scales of 2015 from **8.908%** of the basic pay to **12.052%** of basic pay per month from 1<sup>st</sup> January, 2015. The Government has further ordered revising the rates of Dearness Allowance in respect of those who are drawing pay in RPS-2010 from **77.896%** of the basic pay to **83.032%** of basic pay per month from 1<sup>st</sup> January, 2015 in the Pay Scales of 2010.

In pursuance of the above orders, the rate of Dearness Allowance is revised from **8.908%** of the basic pay to **12.052%** of the basic pay per month with effect from 1<sup>st</sup> January, 2015 and is made applicable to all the regular employees of the Corporation who are drawing their pay in the Revised Pay Scales of 2015 and Dearness Allowance in respect of those drawing pay in RPS-2010 is also revised from **77.896%** of the basic pay to **83.032%** of the basic pay per month from 1<sup>st</sup> January, 2015.

All the regular employees of the Corporation who are drawing Revised Pay Scales of 2015 and 2010 are permitted to draw the arrears of Dearness Allowance in cash for the months of January, 2015 to August, 2015. The Dearness Allowance in respect of Government Officers who are presently working on deputation in this Corporation and drawing their pay in the Revised Pay Scales of 2015 and 2010 shall be paid in cash from the month of September, 2015 and arrears drawn from 01-01-2015 to 31-08-2015 shall be credited to the GPF Account of the respective Government employee, as per the said G.O.

The Dearness Allowance payable to the unskilled workers who are being paid remuneration as per G.O.Ms.No.171, Finance, dt.13-05-2010 in the Corporation, is also revised from **77.896%** of the basic pay to **83.032%** w.e.f. **1<sup>st</sup> January, 2015** and arrears from 01-01-2015 to 31-08-2015 shall be paid in cash.

The General Manager (F&A), Corporate Office, Hyderabad and all Drawing and Disbursing Officers at IMFL Depots are instructed to take action accordingly.
