## II) Additional House Rent Allowance:

The rate of Additional House Rent Allowance is revised to 8% of the basic pay of the employee under the Revised Pay Scales, 2015, subject to a maximum of Rs.2,000/- per month with effect from 1-4-2015, in cases, where rent free accommodation could not be provided by the Government to the employees holding the posts to which rent free accommodation shall be provided by Government as per rules.
