Sub:- Procurement of IMFL (other than Beer) w.e.f. 02.06.2014 -  
Proforma on Rate Contract Agreement - communicated - Reg.

The attention of all the suppliers is invited to the subject and is aware that consequent to "The Andhra Pradesh Reorganisation Act, 2014" (Act No.6 of 2014) a new state to be known as the State of Telangana comprising the territories as indicated in the Act, was formed on and from the appointed day i.e. 02.06.2014. Since, then the State of Telangana has issued the following Government Orders for its adaptation relating to Prohibition & Excise Act, Laws, Rules & Regulation of Trading of IMFL & FL etc.,

- a. The Government of Telangana vide G.O.Ms.No.4 Revenue (Excise-II) Department dated 23-06-2014 reconstituted the Board with new officers as Directors on Board of Corporation under Articles of Association.
- b. The Government of Telangana vide G.O.Ms.No.162 Revenue (Excise-II) Department dated 10-09-2015 adapted the Andhra Pradesh Excise Act 1968 called as "the Andhra Pradesh Excise Act, 1968" (Telangana Adaption) Order, 2015.
- c. The Government of Telangana vide G.O.Ms.No.184 Revenue (Excise-II) Department dated 26-09-2015 adapted the Andhra Pradesh Excise (Import, Export and Transport of etc., permits ) Rules, 2005 called as "The Andhra Pradesh Excise (Import, Export and Transport of Indian made foreign liquor and foreign Liquor - permits ) Rules, 2005" (Telangana Adaption) Order, 2015.
- d. The Government of Telangana vide Letter No.9281/Ex-II(1)/2015-6, dated 05.11.2015 extended the present Rate Contract Agreements(2012-13) for procurement of IMFL (other than Beer) on the same terms and conditions, beyond 15.11.2015 and till the date of finalization of implementation of the revised rates.
- e. G.O. Ms.31 Revenue (CT-II) Department Dt.23.03.2015

Adaptation of "The Andhra Pradesh Value Added Tax Rules 2005" to the State of "Telangana"

f. Govt. Letter No.9281/Ex-II(1)/2015-1, Dt. 02.07.2015

Orders of the Government on extending liquor rate contracts of 2012-13 on existing terms and conditions for a further period of three (3) months i.e. from 01-07-2015 to 30.09.2015.

g. Govt. Letter No.9281/Ex-II(1)/2015-2, Dt. 20.07.2015

Orders of the Government to issue fresh offer notification for supply of Indian Made foreign Liquor (other than Beer) for the year 2015-2016.

h. Govt. Letter No.9281/Ex-II(1)/2015-3, Dt. 05.10.2015

Orders of the Government on extending liquor rate contracts by one month i.e. upto 31.10.2015 or till to the date of finalization of revised rates, whichever is earlier.

i. The Government vide letter No.9281/Ex-II(1)/2015-6, dated 05.11.2015 extended the then prevailing Rate Contracts Agreements (2012-13) for procurement of IMFL (other than Beer) on the same terms and conditions, beyond 15.11.2015 and till the date of finalization of implementation of the revised rates.

j. The Government of Telangana vide G.O.Ms.No.6 Revenue (Excise-II) Department dated 06-01-2016 adapted the Andhra Pradesh Prohibition Act 1995 called as "The Andhra Pradesh Prohibition Act, 1995" (Telangana Adaption) Order, 2015.

k. The Government of Telangana vide G.O.Ms.No.7 Revenue (Excise-II) Department dated 06-01-2016 adapted the Andhra Pradesh (Regulation of Trade in IMFL, FL) Act 1993 called as "The Andhra Pradesh (Regulation of Trade in Indian Made Foreign Liquor, Foreign Liquor) Act 1993" (Telangana Adaption) Order, 2015.

l. The Government of Telangana vide G.O.Ms.No.73 Revenue (Excise-II) Department dated 16-05-2016 adapted the Andhra Pradesh (Regulation of Trade in IMFL, FL) Rules 1993 called as "The Andhra Pradesh (Regulation of Trade in Indian Made Foreign Liquor, Foreign Liquor) Rules 1993" (Telangana Adaption) Order, 2016.

m. The Government vide letter No.23883/Ex-II(2)/2015-3, dated 11-05-2016 permitted the Corporation to utilize the physical infrastructure (Assets) i.e. 17 Depots and Corporate office which are distributed prior to bifurcation of the State and to carry on business and other activities as directed by the Government of Telangana from time to time, on behalf of the Government of Telangana State.

In view of the above, the Corporation (on behalf of the Government) decided that the Terms and Conditions of Rate Contract Agreement which are already operative with effect from 02.06.2014 be reduced into writing.

Therefore, a prescribed format for entering into Rate Contract Agreement for supply of IMFL (other than Beer) is prepared and enclosed along with an ANNEXURE showing approved brands/sizes with Basic prices which are operative w.e.f. 02.06.2014, for taking further action from your end.

The following guidelines / Instructions are issued for submitting the Rate Contract Agreement.

1. Submit along with the Rate Contract Agreement name and designation of the officer who is authorized to sign the Rate Contract Agreement duly specifying the period of Rate Contract Agreement along with the Board of Director's resolution authorizing the said officer duly attested by the Company Secretary.
2. Name and designation of the officer authorized to receive letters, Cheques / payments Circulars etc., and also authorized to correspond with the Corporation, along with his photo identity and specimen signature duly attested.


Further all the suppliers are directed to submit the Rate Contract Agreement duly filled in and in duplicate, in the TSBCCL Corporate Office by 31st October, 2016, failing to which further action as deemed fit i.e. with holding release of "Orders for Supply", recommending the CPE to withhold all the sale proceeds etc., will be taken against them.
