Sub: Deputation of T.S.Housing Corporation employees - Sanction of Conveyance Allowance and Medical Reimbursement and Surrender Leave - Reg:

The services of 58 employees of Telangana State Housing Corporation were drawn on deputation and 57 employees have joined and they are at present working at IMFL Depots as Asst. Stores Officer Gr.-II.

As per Lr.dt. 06-08-2016 addressed to the MD, TSHCL, the service matters of the candidates will be dealt by the TSHCL as per Minutes of the meeting on Redeployment of TSHCL employees on 14-07-2016. The terms and conditions of Foreign Service will be as per the adapted APBCL Service Regulations 2009 or the guidelines on deputation to be issued by the Finance Department, Telangana Secretariat, Hyderabad as per the said Minutes of the meeting. However, the guidelines from Finance Department are not received yet.

In view of the above, the employees of Telangana State Housing Corporation presently working on deputation are allowed the following till the guidelines are received from the Finance Department.

i)Pay and Allowances: pay and allowances as admissible from time to time in the parent organisation shall be paid. However, HRA, CCA shall be paid as admissible at the places of working.

ii)LTC: The deputationist may be allowed the LTC as per rules and liability in respect of such expenditure shall be borne by the foreign employer in full.

iii)Educational concession, Medical Reimbursement and Conveyance Allowance: The deputationist may be allowed Educational Concession, Medical Reimbursement, Conveyance Allowance as per the rules of the Adapted APBCL Service Regulations and liability in this regard shall be borne by the foreign employer.

- vi) Leave: The deputationist is allowed to earn Earned Leave and Half Pay Leave from the date of joining, as per the rules of TSBCL. Earned Leave/Half Pay Leave account shall be maintained separately.
- vii) Encashment of Earned Leave: The deputationist is allowed to encash Earned Leave from the Earned Leave earned while serving at TSBCL @ 15 days for each financial year as per the rules of TSBCL.

The Chief Managers/Managers of IMFL Depots in the State are requested to take action accordingly.
