In view of the above, we all the Chief Managers | Managers are requested to take up the issue immediately with ESI authorities for registration and enrolment of Unskilled workers with ESI authorities under ESI Act and Labour laws to avoid any penalty by ESI authorities. The deduction of contributions towards ESI should be effected from 1st January, 2017 onwards as per the notification issued by ESI authorities.

G.S.R. 1166(E).—Whereas centile draft rules further to amend the Employees' State Insurance (Central) Rules, 1950 were published in the Greatte of Employees Part II, section 3, sub-section (i) vide number G.S.R. 957(F), dated the 6° October, 2016, as required by sub-section (1) of section 95 of the Employees' State Insurance Act; 1948 (34 of 1948), inviting objections and suggesticits; Built all persons likely to be affected thereby before the expiry of a period of thirty days from the date on which the copies of the Official Gazette in which the said notification was published were made available to the public;

And whereas, the copies of the said Cifficial Gazette were made available to the public on the 6th October, 2016;

And whereas, objections and suggestions received from persons likely to be affected thereby have been considered by the Central Government;

Now, therefore, in exercise of the powers confined by section 95 of the said Act, the Central Government, after consultation with the Employees! State Insurance Corporation, hereby makes the following rules fluther to assend the Employees! State Insurance (Central) Rules, 1950, namely:

- 1. (1) These rules may be called the Employees' State Insurance (Central) Third Amendment Rules, 2016.
 - (2) They shall come into force from: 1" day of Jamacy, 2017.
- 2. In the Employees! State Insurance (Central) Rules, 1950, in rule 50, for the words "lifteen thousand rupees" occurring at both the places, the words 'twenty one thousand rupees" shall be substituted.
