All the FL suppliers were requested vide Cr.No. TSBCL/K/RCA/2018-19/3582 dt:07-06-2018, to submit their consents for continuing the supply of Foreign Liquor beyond 30-06-2018 at the prevailing Assessable values (Basic Price) and same terms & conditions of existing Rate Contract Agreement, upto 30-06-2019 OR till finalization of Tender Committee Report for the year 2017-18 by the Government of Telangana, Whichever is earlier.

Accordingly, all the FL suppliers have given consents for the same.

In this regard, it is further submitted that a detailed report to the Government was submitted vide reference 2<sup>nd</sup> cited along with Tender Committee Report and TSBCL Board recommendations, seeking implementation of Tender Committee Report for FL brands. The Government orders are awaited.

The consents given by the Foreign Liquor suppliers for supply of Foreign Liquor at the existing Rate Contract Agreements are expiring on 30-06-2019.


In view of the above, we may request all the FL suppliers to give consents for continuing the supply of Foreign Liquor at the existing rates and terms & conditions beyond 30-06-2019 and upto 30-06-2020 or till to the date of the finalization of the Tender for the year 2017-18, whichever is earlier.
