Sub: Permission for establishment of Wholesale Depot for possession
and sale of IMFL & FL by IMFL depots – renewal of existing permission (s)-Reg.

The attention of all the Chief Manger (s) / Manager (s) of IMFL depots is invited to the subject cited.

The then state of Andhra Pradesh has enacted an act 15 of 1993 under the title Regulation of Trade in Indian Made Foreign Liquor, Foreign Liquor, Act, 1993.

As per section 4 of the then Andhra Pradesh (Regulation of Trade in Indian Made Foreign Liquor, Foreign Liquor, Act, 1993 {Act No.15 of 1993} [as amended by Act No.17 of 2006], the right to carry on wholesale trade and distribution of Indian Liquor, Foreign Liquor, Wine and Beer solely vest in the Government and subject to such rules as may be made in this behalf the ANDHRA PRADESH BEVERAGES CORPORATION LIMITED, a Corporation wholly owned and controlled by the Government has the exclusive privilege of importing, exporting and carrying on the wholesale trade and distribution of Indian Made Foreign Liquor, Foreign Liquor, Wine and Beer on behalf of the Government, for whole of the State of Andhra Pradesh and no other person shall be entitled to any privilege of importing, exporting and supplying the same in wholesale or distributing the same for the whole or any part of the State.

Accordingly the then Andhra Pradesh Beverages Corporation Limited established Wholesale depots at each district of the then state of Andhra Pradesh, for carrying on the wholesale trade and distribution of Indian Made Foreign Liquor, Foreign Liquor, Wine and Beer on behalf of the Government. The Commissioner of Prohibition & Excise of the then Government of Andhra Pradesh has accorded permission to store and carry out IMFL & FL trade by these Wholesale depots under rule '6' of Andhra Pradesh (regulation of trade in Indian Liquor, Foreign Liquor) rules, 1993. The permission of all these whole sale depots are renewed from time to time by the CPE.

Telangana State Beverages Corporation Limited is created vide G.O.Ms.No.246 Rev (Ex-II) Dept dated 29-05-2014 cited consequent to "The A.P.Re-organisation Act-2014" for taking up whole sale trading of IMFL and FL in the state of Telangana.

The validity permitted ~~06~~ '17' IMFL depots functioning in the state of Telangana located in various districts and '5' additional godowns taken on hire in the districts of Nizamabad, Karimnagar, Mahaboobnagar, Khammam and Warangal is going to expire shortly.

Under rule '9' of Andhra Pradesh (regulation of trade in Indian Liquor, Foreign Liquor) rules, 1993 application for renewal of permission granted under rule '6' shall be made by the Corporation in form FW-I at least 30 days in advance of the date of expiry of the validity thereof. Form FW-I of the application is to be accompanied by true copies of location plans and plans of the building in triplicate along with boundaries.

In view of the above, all the Chief Manager (s) / Manager (s) of IMFL depots are hereby directed to submit attested true copies of location plans and plans of the building in triplicate along with boundaries within '15' days from the date of receipt of the circular for taking further action.

The matter may be treated as urgent.
