- The Government of Andhra Pradesh vide G.O.3rd cited, communicated the guidelines for final allocation of State Cadre employees under A.P.Reorganisation Act 2014. As per the said guidelines, it was decided that all actions will be jointly done by the two Corporations in mutual consultation with each other.
- 2) Accordingly, the guidelines on allocation of personnel in State cadre/zonal cadre are framed with reference to the guidelines issued by the Government vide G.O. 3rd cited, and communicated to the employees of both the Corporations vide this office Circular 6th and 7th cited above and called for options from the employees except for the cadres of Assistant Stores Officers (Grade-I and II) / Jamedar Sweepers/Sweepers, for their allocation to TSBCL/APBCL along with supporting certificates/documents.
- 3) The employees of both the Corporations have submitted their options preferring to be allocated to APBCL/TSBCL and all the options received from the employees of APBCL and TSBCL are consolidated and placed before the Senior Officers Committee constituted vide Procs.No.A2/73/2013/876,dt.18-02-2015, for scrutinizing the options by taking into consideration the guidelines, factual accuracy of the statements made therein and as certified, the seniority, nativity, Study Certificates etc., and recommend the allocable employees between both the Corporations i.e., APBCL/TSBCL.
- 4) The Senior Officers Committee met 02-03-2015, 04-03-2015, 07-03-2015 and on 09-03-2015 and scrutinized the options submitted by the employees duly taking into consideration the guidelines, factual accuracy of the statements

made therein and as certified, the seniority, nativity, Study Certificates, Supporting documents etc., and submitted its report on 20-03-2015 recommending allocation of employees between APBCL/TSBCL.

- 5) The recommendations of the Senior Officers Committee on allocation of employees between the APBCL/TSBCL are accepted. A Tentative list of allocation of employees between APBCL/TSBCL is prepared and communicated herewith to all the employees working in the Corporation. The Tentative List of allocation of employees enclosed herewith and is also available in eMAIL ID: tsbclpersonnel@gmail.com and apbclpersonnel@gmail.com.
- 6) In order to ensure accuracy, authenticity and to ensure that the process of allocation is effective, it is decided to call for objections from the employees, if any.
- 7) On communication of Tentative allocation Lists, an employee who feels aggrieved by his/her tentative allocation may submit representation against his/her allocation to the respective Managing Directors of APBCL/TSBCL in which he/she is serving within (14) days from the date of receipt of this Circular, for placing the same before the Senior Officers Committee for consideration.
- 8) If, no, grievance representation is received from an employee against tentative allocation list, such employee is deemed to have been allocated to the Corporation to which he/she is allotted tentatively.
- 9) The Senior Officers Committee shall give opportunity to those aggrieved employees for personal hearing and submit their findings to both the Managing Directors.
