The Chief Managers/Managers of IMfL Depots have engaged Computer Personnel on outsource basis through Service Provider at district level in a required manner in pursuance of the orders issued on various occasions, for computer operations at IMFL Depots in the State.

It is observed that most of the outsourcing computer personnel are working at IMFL Depots since 10 to 15 years with the same Service provider on renewal of contract period. It is not desirable to continue the outsourcing computer personnel for such longer periods in the interest of the Corporation. Hence, it is decided to terminate the existing contract with the present outsourcing Service Provider by giving one month Notice and engage computer outsourcing personnel afresh with new Service Provider by entering into fresh Agreement with the existing remuneration and terms and conditions already communicated.

In view of the above, all the Chief Managers/Managers of IMFL Depots in the State of Telangana are requested to terminate the existing contract with the present outsourcing Service Provider by giving one month Notice, and engage computer outsourcing personnel afresh as per the existing strength, with new Service Provider by entering into fresh Agreement with the existing remuneration and terms and conditions already communicated.

The draft agreement be got vetted by the Corporate Office, Hyderabad along with required details of registration of outsourcing Agency, P.F. and ESI, Service Tax etc.,
