Through this office Circular 9th cited, it has been directed to terminate the existing contract with the present outsourcing Service Provider by giving one month Notice and engage computer outsourcing personnel afresh with new Service Provider by entering into-fresh Agreement. It is noticed that none of the Data Entry Operators are replaced and allowed to continue till date. The information from only RR-I has been received and the information has not been received from other depots.

While the matter stood thus, it has been brought to the notice that many of the outsourced DEOs, have become agents for certain individuals and reportedly indulging in certain iflegal activities with connivance of certain regular employees and they are also altering online Indents without the approval of the Chief Manager/Manager in collusion with the supplier representatives which would damage the reputation of the Corporation. There is an urgent need to curb such Illegal activities in the interest of an Organisation.

In view of the above, the Chief Managers/Managers are directed to terminate the contract of the outsourcing Agency who are longstanding, If so far not done, and ask the outsourcing Agency to provide Data Entry Operators afresh and see that they should be changed frequently i.e., for every (06) months.

Further, it is directed to furnish the information in the prescribed format enclosed herewith, relating to the existing Data Entry Operator for taking further action in the matter.

The receipt of Circular be acknowledged and the orders issued should be complied with Immediate effect. Otherwise, sultable disciplinary action will be initiated against the Chief Manager/Manager under relevant rules.
