Sub: Personnel - TSBCL - Enhancement of D.A. to the regular employees of the Corporation and Government employees working on deputation who are drawing their pay in the Revised Pay Scales of 2015, 2010 and also Unskilled Workers - Orders Issued - Reg

The Government vide G.O. cited, have issued orders revising the rates of Dearness Allowance to the State Government Employees drawing pay in the Revised Pay Scales with effect from 1<sup>st</sup> July, 2016 which are as follows.

Sl.No	Description	Enhanced from	Enhanced to	Revised Pay Scales
1	Dearness Allowance	18.34%	22.008%	RPS-2015
2	Dearness Allowance	93.304%	99.296%	RPS-2010

In pursuance of the above orders, the rate of Dearness Allowance is revised as mentioned above with effect from 1<sup>st</sup> July, 2016 per month, and extended to all the regular employees of the Corporation and the employees working on deputation, who are drawing their pay in the RPS-2015, 2010.

All the regular employees of the Corporation who are drawing the Revised Pay Scales of 2015, 2010, are permitted to draw the arrears of Dearness Allowance in cash for the months of July, 2016 to March, 2017. The Dearness Allowance in respect of Government Officers who are presently working on deputation in this Corporation and drawing their pay in the Revised Pay Scales of 2015, 2010, shall be paid in cash with the salary of April, 2017. However, the arrears on account of payment of Dearness Allowance for the period from 1<sup>st</sup> July, 2016 to 31<sup>st</sup> March, 2017 shall be credited to the General Provident Fund Account of the respective employees working on deputation, as per the said G.O.

The Dearness Allowance payable to the unskilled workers who are being paid basic pay of Rs.13,000/- + Allowance in the Revised Pay Scales of 2015 in pursuance of the orders issued in Govt Lr.No. 17664/Ex-II(2)/2015-3, Dated:15-12-2016 is also revised as mentioned above, **w.e.f. 1<sup>st</sup> July, 2016** and the arrears from 01-07-2016 to 31-03-2017 shall be paid in cash.

The General Manager (F&A), Corporate Office, Hyderabad and all Drawing and Disbursing Officers at IMFL Depots are instructed to take action accordingly.
