The attention of Chief Managers / Managers is invited to the subject cited above. They are informed that **M/s GK Electronics, Hyd** has quoted the Lowest price for Monthly Maintenance Contract (MMC) to maintainance CCTVs at 15 IMFL Depots with the terms and conditions as below.

**TERMS AND CONDITIONS:**

- 1) The Monthly Maintenance Contract(MMC) period will be for one year. i.e. 01.05.2017 to 30.04.2018.
- 2) The Cost of MMC for each Depot is Rs.1,400/- Per Month (excluding Taxes).
- 3) The payment will be made in (4) Four equal installments at Coporate Office.
- 4) The 1<sup>st</sup> payment will be released along with MMC order. The remaining payment will be made only after completion of every quarter.
- 5) The MMC payments will be made by TSBCL, Coporate office on production satisfactory service report from each depot in the state.
- 6) The MMC vendor will visit once in a Month to all IMFL Depots to carry out the Regular Maintenance and shall produce service report to that effect.
- 7) The Depots should call Maintenance Vendor, if there are any breakdowns in the system. The vendor shall attend within 48 hours.
- 8) If any breakdown of Camera(s), the Vendor will replace new camera(s) with in a Week. Failure on part of the Vendor Rs. 500.00 will be charged from the Vendor per day as penalty for the breakdown period.
- 9) The Corrective Maintenance and call reports attended by the Vendor signed by the Depot Manager during the visit should be submitted to the Coporate Office at the end of the Quarter. A Log book shall be maintained by the depot logging the break down and repairs and attendance by Maintainace Vendor.
- 10) TDS will be deducted as per rules in vogue.
- 11) TSBCL may terminate this contract by giving one month notice during the contract period if the services are found unsatisfactory, duly deducting relevant period maintenance charges proportionately.
- 12) Jurisdiction: All and any disputes of difference arising out of or touching this order shall be decided only by the Courts or Tribunals situated in Hyderabad / Secunderabad.


